INVESTIGATIVE SUMMARY:

This is an "Operation Iraqi Freedom" Investigation.

b7C, b6A This investigation was initiated based on notification from 1LT [redacted], 115th Military Police (MP) Battalion (BN), Camp Cropper, Baghdad International Airport (BIAP), APO AE 09335, concerning the death of an Iraqi National detainee.

Investigation failed to prove the cause or manner of death for Mr. AL-OBIDI.

On 3 Aug 03, MAJ (MD) [redacted] b7C, b6A, B Company, 109th Area Support Medical Battalion (ASMB), BIAP, pronounced the victim dead. MAJ [redacted] b7C, b6A noted no external injuries were evident and he believed the victim died of cardio respiratory arrest.

All investigative efforts to confirm the victim was transported to the United States or Germany for an autopsy have met with negative results. Further coordination's with Mortuary Affairs, BIAP and the aforementioned medical unit produced no record as to whom the body was released to.

Numerous witness statements from detainees and military police consistently reported the victim appeared extremely ill prior to his death. No evidence exists to contradict the findings of the medical doctor who pronounced the victim dead.

Basis For Investigation: About 1620, 3 Aug 03, this office was notified by 1LT [redacted] 115th Military Police Battalion (MP BN), Camp Cropper, Baghdad International Airport, APO AE 09335 (BIAP), of the death of civilian detainee #13608, identified as Mr. Jassim Mohammed Saleh Hussain AL-OBODI, a 38 year old Iraqi male, after Mr. AL-OBODI collapsed at the compound and was transported to 109th Area Support Medical Battalion (ASMB), BIAP.

At 1700, 3 Aug 03, SA [redacted] interviewed and obtained a Sworn Statement from MAJ (Doctor) [redacted] B Company (Co), 109th ASMB, BIAP. MAJ [redacted] stated he attempted Cardio Pulmonary Resuscitation (CPR) and other life saving measures on Mr. AL-OBODI with negative results and pronounced him dead at 1554, 3 Aug 03. Further, MAJ [redacted] stated noted no external injuries and believed Mr. AL-OBODI died of natural causes, Cardio Respiratory Arrest (see Sworn Statement for details).

SSG [redacted] stated she was notified of a "CPR in progress" call from the Corps Holding Area (CHA) and upon arrival she observed other medics performing CPR on a civilian detainee from the camp. SSG [redacted] noted Mr. AL-OBODI was not breathing, had no pulse, and was evacuated by truck to the 109th ASMB (see Sworn Statement for details).

 At 1745, 3 Aug 03, SA [redacted] interviewed and obtained a Sworn Statement from CPT [redacted] 115th MP BN, Camp Cropper, BIAP. CPT [redacted] stated he was notified of a detainee having collapsed and responded to the CHA to find two medics performing CPR on the detainee. CPT [redacted] noted Mr. AL-OBODI was not breathing and had no pulse and ordered evacuation immediately to 109th ASBM. CPR efforts were continued en route. At the 109th ASMB, resuscitation efforts were unsuccessful and MAJ [redacted] pronounced Mr. AL-OBODI dead at 1554, 3 Aug 03 (see Sworn Statement for details).

The collapsed detainee was placed on a blanket by the other detainees who were instructed to carry him to the medic station. SSG [redacted] noted the time of this occurrence as approximately 1525, 3 Oct 03 (see Sworn Statement for details).

PFC [redacted] observed a group of detainees gather around another detainee lying unresponsive on the ground. PFC [redacted] instructed the detainees to place the man on a blanket and carry him to the medic station. PFC [redacted] noted the medics immediately began CPR and after about ten minutes, the detainee was evacuated from the camp in a truck (see Sworn Statement for details).

CPR was started immediately and CPT [redacted] was notified. Shortly after CPT [redacted] arrival at the CHA, Mr. AL-OBODI was evacuated to 109th ASMB in the back of a truck. SPC [redacted] stated that CPR efforts were maintained throughout the transportation and continued at 109th ASMB until approximately 1554, 3 Oct 03 when MAJ [redacted] pronounced Mr. AL-OBODI dead (see Sworn Statement for details).

noted Mr. AL-OBODI was not breathing and had no pulse. CPR was started immediately and continued throughout the evacuation to 109th ASMB (see Sworn Statement for details).

At 1815, 3 Aug 03, SA [redacted] interviewed and obtained a Sworn Statement from SGT [redacted] 15th MP BN, Camp Cropper, BIAP. SGT [redacted] stated Mr. AL-OBODI was brought to the medical station at approximately 1515, 3 Aug 03, not breathing and with no pulse. CPR was started immediately and continued for 15 to 20 minutes before Mr. AL-OBODI was evacuated to the ASMB.

At 1818, 3 Aug 03, SA [redacted] interviewed and obtained a Sworn Statement from SPC [redacted] 15th MP BN, Camp Cropper, BIAP. SPC [redacted] stated she observed SSG [redacted] and SPC [redacted] performing CPR on an unconscious detainee at the CHA. SPC [redacted] assisted in loading the detainee into a truck for evacuation to 109th ASMB (see Sworn Statement for details).

At 1830, 3 Aug 03, SA [redacted] interviewed and obtained a Sworn Statement from SPC [redacted] 15th MP BN, Camp Cropper, BIAP. SPC [redacted] stated he was informed of a "CPR in progress" call at the CHA. When SPC [redacted] arrived, he observed several medics performing CPR on an unconscious detainee. SPC [redacted] stated the detainee was evacuated to 109th ASMB with CPR continuing throughout transport. Once at 109th ASMB, resuscitation effort continued until the pronouncement of death at 1554, 3 Oct 03 (see Sworn Statement for details).

About 1630, 4 Aug 03, SA [redacted] and Mr. [redacted] a civilian interpreter assigned to this office, interviewed Detainee [redacted] a 27 year old Iraqi male from the Diala area of Baghdad, Iraq, who stated earlier that day Mr. AL-OBODI acted normal and was joking and laughing with the other detainees. While sitting around talking with the other detainees, Mr. AL-OBODI fell to his knees then to the ground onto his right side. Mr. [redacted] explained he thought Mr. AL-OBODI was joking until he noticed AL-OBODI was breathing "very heavy and noisy." Mr. [redacted] called the guards for help and then helped the other detainees carry Mr. AL-OBODI to the aid station.

About 1655, 4 Aug 03, SA [redacted] and Mr. [redacted] a civilian interpreter assigned to this office, interviewed Detainee [redacted] 26 year old Iraqi male from the Shab area of Baghdad, Iraq, who stated Mr. AL-OBODI had not been feeling well on the morning of 3 Aug 03, but seemed to improve as the day went on. After eating, Mr. AL-OBODI was talking and laughing with the other detainees when suddenly, Mr. AL-

OBODI's left arm went stiff and he grabbed his head. Mr. [redacted] stated Mr. AL-OBODI then fell to the ground and was not breathing. Mr. [redacted] and other detainees carried Mr. AL-OBODI to the guards for help.

I, [REDACTED] MCB want to make the following statement under oath:

I received EDW # D13608 in the trauma room of the Co B 109th ASMB - TRAC. He was brought in a stretcher by medics with no spontaneous breathing or palpable pulse.

Cardio pulmonary resuscitation was initiated at 15:40 on 3 Aug 03. When he was connected to the heart monitor there was severe bradycardia (slow heart rhythm) - but without effective cardiac contraction - No pulse or BP.

Code was continued with appropriate measures till 1556 at which time there was no detectable heart electrical activity. Pt remained without pulse, BP or respiration throughout this time and was maintained on CP resuscitation.

There was no evidence of external injury to the pt.

Pronounced dead at 1554
Died of natural causes in my opinion
- Cardio respiratory arrest. Nothing follows

I want to make the following statement under oath:

On August 3, 2003, at approximately 1520 I responded to a "CPR in progress" call from the CHA. The call for an ambulance was relayed to CPL [REDACTED] who phoned the 109th. When I arrived at the CHA SSG [REDACTED] was performing CPR compressions + SPC [REDACTED] was rescue breathing. I initiated an IV line in the @ AC to new Ringer's lactate. IV 18 gauge x 1 attempt. Cpt [REDACTED] was checking for responsiveness + listening for a pulse. At this time the Pt remained pulseless + fixed + dilated pupils. CPR was only interrupted to check for a pulse. Pt was intubated + additional O₂ was provided thru CPR mask. The patient was loaded into a 2 1/2 ton vehicle + transported to the 109th hospital by SPC [REDACTED], driver, Cpt [REDACTED], myself, SPC [REDACTED], SPC [REDACTED] + the MP escort. CPR continued enroute. Upon arrival @ 109th the patient was placed on 3 lead ECG, O₂ + an ET tube was placed. Lung sounds were fluid filled (as they were in CHA) making ET tube placement ~~after~~ verification difficult. CPR continued, medications were pushed, another IV line was placed in @ foot. Section was performed. NG tube was placed @ difficulty - @ stomach contents removed. Pt had vomited small amount of blood tinged foam from mouth. Pt was in PEA + defibrillated @ good results. Pt remained in PEA + then went into Asystole. Code called. Time of death 1554. Dr. [REDACTED] pronounced death @ 109th.

On August 3, 2003 I was a cage guard for Delta compound at Camp Cropper Corps Holding Area. At about 1525 a man came up to the gate and told me there was "a very sick man." I looked back to where he was pointing and saw some other prisoners lifting a detainee's arms and legs that was laying in the back tent. He appeared to be nonresponsive. I told them to grab his blanket he was laying on and carry him up to the med station. On the way to the medic tent I noticed the guy had a gray color in his face and I informed the five prisoners carrying him to hurry. When we arrived in the medical tent I noticed the medics began administering CPR immediately and informed everyone to leave the tent, except the medics. I waited outside to get the prisoner's ISN number to record in the logbook. At about 1535, after the ambulance did not show up, the medics loaded the man into the back of a Quee and took him to 109th hospital. SPC *[REDACTED] b7C, b6A* yelled out the detainee's number to me out the back of the truck as they were driving away. The ISN number was 13608.

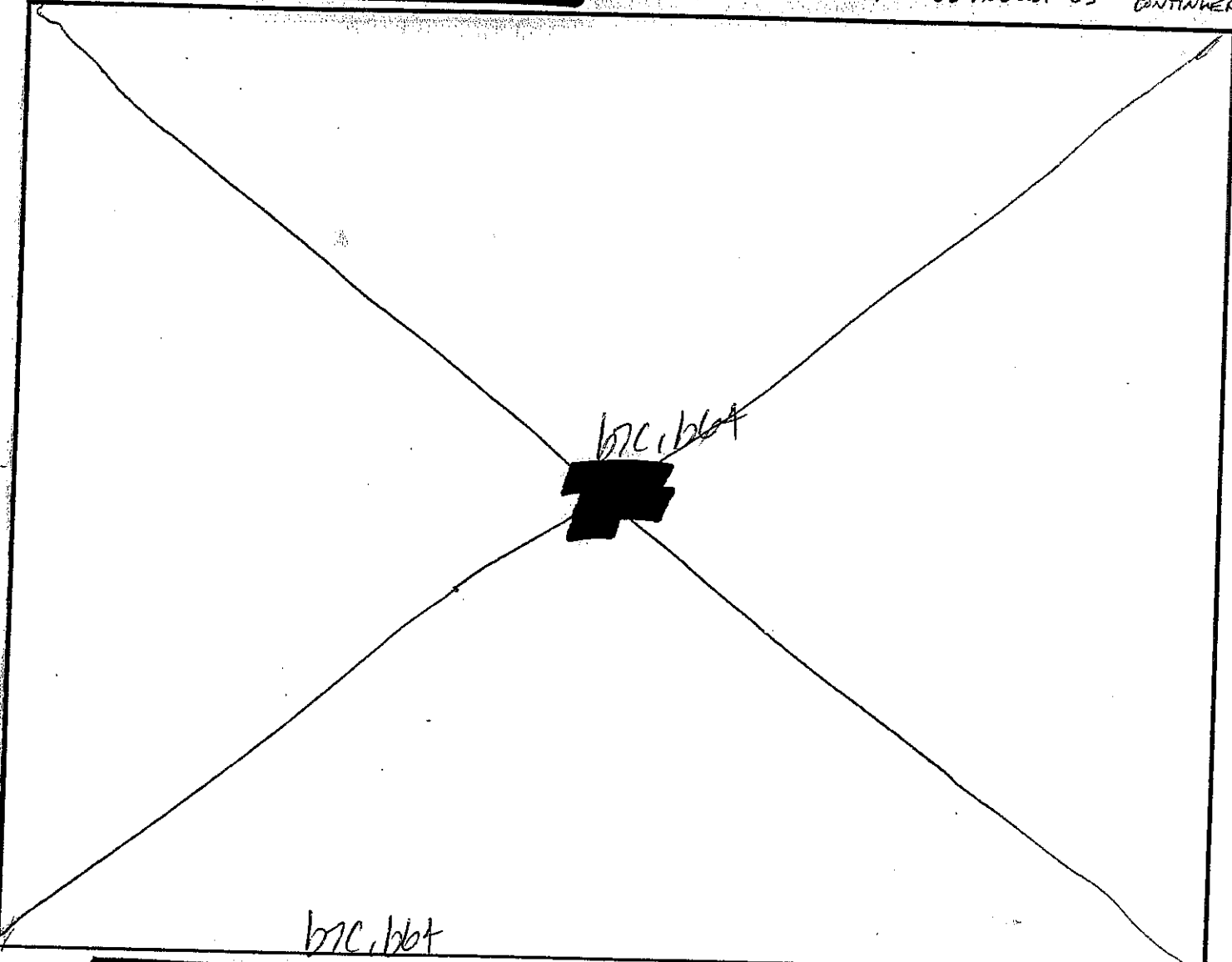

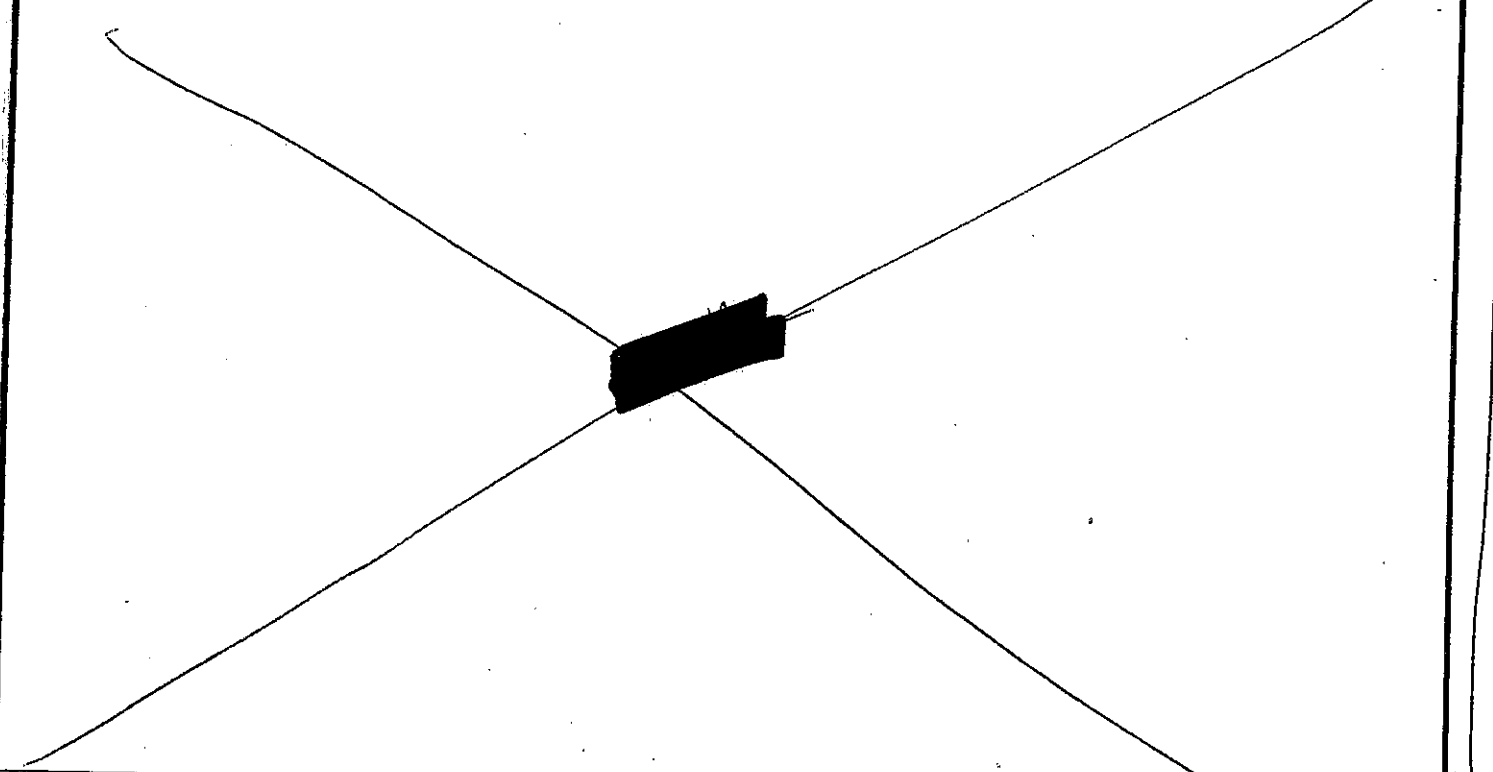

BASIS FOR INVESTIGATION: On 20 Dec 03, this office received a telephonic Request for Assistance (RFA) from the 12th Military Police Detachment (CID) (MINUS), LSA Anaconda, Iraq APO AE 09391, requesting this office obtain a certificate of death for Mr. Jassim Mohammed Saleh Hussain AL-OBODI, ISN 136608 (NFI), a detainee at Camp Cropper, Baghdad, Iraq, who died of an apparent heart attack on 3 Aug 03.

At 1353, 23 Dec 03, SA [redacted] coordinated with SGT [redacted] Administrative Assistant, Bravo Company, 109th Area Support Medical Battalion, Vermillion, SD (Baghdad, Iraq), who related she remembered the day AL-OBODI came to the clinic, but he was dead on arrival, and therefore their office did not produce a certificate of death for the victim. SGT [redacted] also related all the doctors that were here at that time had rotated back to the U.S. SGT [redacted] further related the 115th Military Police Company that had been at Camp Cropper had rotated out of Iraq. SGT [redacted] related there was a possibility the morgue may have obtained a copy of the certificate of death for their records after the body was sent there.

At 1430, 23 Dec 03, SA [redacted] coordinated with SSG [redacted] 54th Quartermaster Company, Fort Lee, VA (Baghdad, Iraq), who related he was not assigned to the unit when the body went through the morgue. SSG [redacted] conducted an extensive search of his records, but was unable to find any documentation regarding AL-OBODI.

STATUS: This RFA is closed in the files of this office. No further investigative activity was anticipated.
